### INSTRUCTIONAL AREAS

#### SELECTION & HIRING PROCESS

Students will be exposed to organizational responsibility for creating a sound background process and current and emerging trends for selection and hiring staff.

#### LEGAL LIABILITY IMPLICATIONS

Identifying legal requirements relating to applicant suitability and qualifications, Social Media hiring laws, Qualified Privilege and employer references, Employment Civil Rights, PDA, ADA, ADEA, EEOC, GINA, USERRA, FCRA, Criminal Records Expungement and Civil Rights Relief Acts that can impact future negligence and liability for an organization.

#### BACKGROUND INVESTIGATION PROCESS

A four-step process that includes review of Personal History Statements and identifying Red Flags, Interview Tactics and Strategies, Verification and Checking Data, Comparison and Analysis of Application Information.

#### SOURCES OF INFORMATION

Identifying investigative resources including Government and Public Sectors, Military Service Records (DD214) Records Verification, and Internet Websites.

#### FORMS, REPORTS, & RECORDKEEPING

Examples of standardized procedures, forms, and checklists, investigative reports, and background files and restricted information access laws.

### COURSE INFORMATION

Personnel in Law Enforcement, Public Safety, Communications, Detention/Corrections, HR and Legal Departments, Fire, EMS, and Government staff who conduct or oversee the hiring, background investigation, and selection processes.
